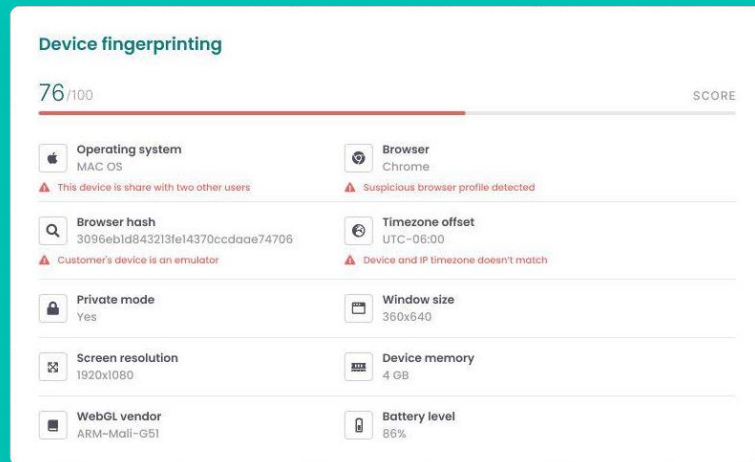
# Device Fingerprinting

We **modernize device fingerprinting** to give you **device intelligence**.

Tracking invisible device settings so that you can identify unnoticeable fraud rings & large-scale bot attacks. Highlighting multi-accounting attempts because we can see users who are sharing the same browsers and devices.

**Detects unusual software and hardware settings** such as:

- Browsers specifically designed to get around existing fraud solutions
- Privacy browsers, suspicious browsers, browser spoofing
- Browser anti-fingerprinting extensions
- Common combinations of bots, automation or testing tools
- Virtual machine environments, emulators
- Rare browser environments and screen resolutions

- iOS and Android SDKs for mobiles
- On-premise installations for those who need to keep data on site
- Frictionless customer experience, unnoticeable for users
- Risk scoring by SEON's engine gives accuracy flagging suspicious users

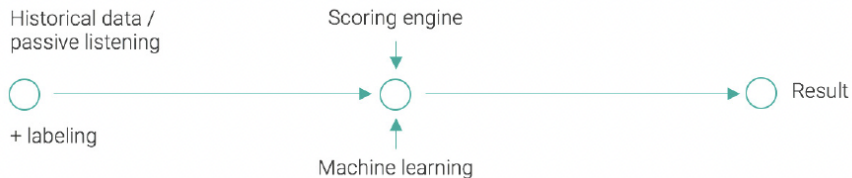

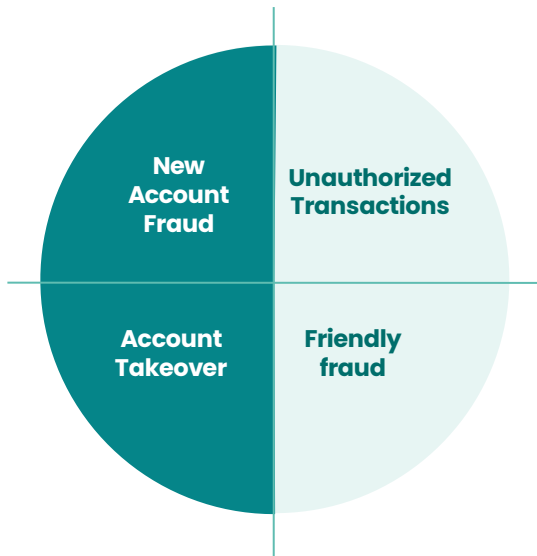

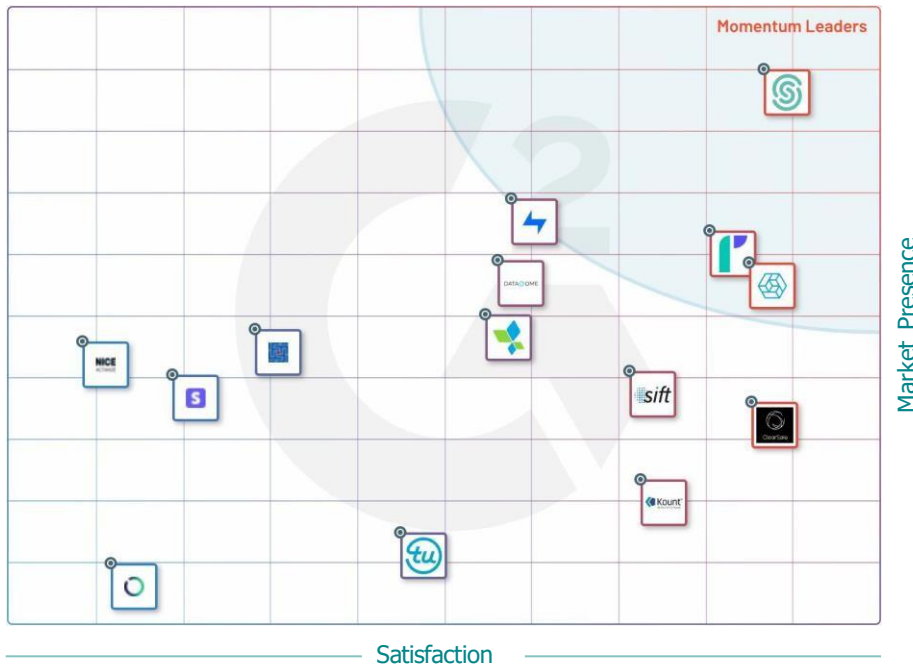
